FAM Global Opportunities Plus Fund 'FGO+' seeks long-term growth of the portfolio by investing opportunistically across asset classes, geographies, and sectors. Instead of investing in flavour of the day concepts, the strategy focuses on performance drivers that make sense and are backed by empirical research.

Smoother Ride

By harnessing the power of diversification, a multi-asset approach into traditional and alternative assets provides stability and a less stressful investment journey. FGO+ generally allocates up to 60% in equities and is expected to generate higher returns than FGO.

Markets exhibit trends and cycles that create ongoing opportunities to invest in. Using Fundamental, Valuation, and Technical principles; we aim to invest into differentiated markets with favourable risk/reward that can deliver long-term outperformance.

Efficient Access

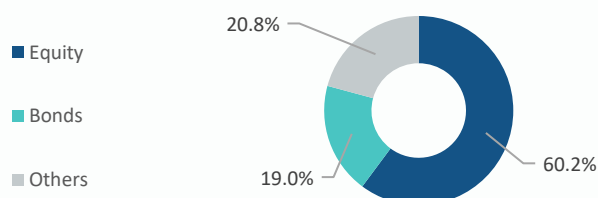
Invest into best-in-class investment managers, and low-cost ETFs to gain effective and targeted exposures to differentiated market segments.



Fundamental, Valuation, and Technical

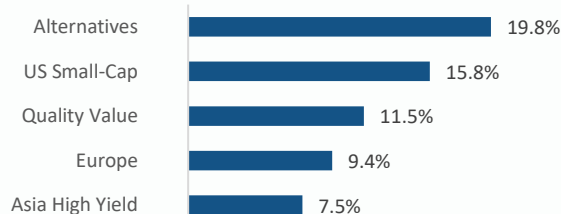
Identify pockets of value supported by favourable tailwinds, and higher likelihood of gains. The three-pronged approach forms the cornerstone of our investments.

Market & Portfolio Developments

Market Review

June was a tough month. Inflation and rate hike fears continued to plunge markets across the board after what seemed like a breather last month. Global equities were down 8.40% and bonds, supposedly a safe haven asset, were down 3.21%. Only a few spots were green in a sea of red – trend-following alternatives was one area that witnessed positive returns.

Main Contributors 'What did well?'

Our **Trend-following Alternatives** contributed positively to returns despite market weaknesses and remain an important true diversifier of returns, especially in an environment where equities and bonds move in lockstep. On the same note, our patience in **China 'A' equities**, which we deemed to have favourable FVT, paid off on the back of improved sentiments after the Chinese government ended months of lockdowns.

Main Detractors 'What underperformed?'

European equities detracted from performance as news of a European Central Bank rate hike, alongside slowing business activity hit investor sentiment. **Emerging market bonds** were the other detractor, which declined on the back of rising interest rates and risk-off appetite as investors feared insolvency issues by bond issuers in developing economies.

Portfolio Activity

During the month we re-allocated global credit positions into a sovereign bond strategy expected to be more resilient without giving up on return potential.

Market Outlook

Inflation and interest rate hikes may have led many to predict an oncoming recession, but experienced investors know that such is the ebb and flow of the market cycle that rewards patience and preparation rather than timing market entries and exits. Investing in periods of market decline can be painful, but it provides investors with invaluable opportunities to achieve better future returns - only if they have patience and a long investment horizon.
