Market & Portfolio Developments

Commentary

As traditional equity and bond markets grappled with uncertainties surrounding the Federal Reserve's interest rate path and potential recessions, FAI remained resilient, returning 1.2% in June and bringing year-to-date returns to 7.2%.

The strategy's focus on non-traditional 'alternative' income assets has led to the current streak of positive returns since the inception of the strategy. We are encouraged by the strong start, especially as this period was marked by volatile markets and economic concerns. On the back of the solid performance, FAI is paying out an attractive first dividend of \$3, and an additional \$2.4 as a special dividend (\$5.4 total payout) – exceeding the initial semi-annual target of \$3.

While we should not expect gains to be positive every month, we remain optimistic about delivering attractive and steady income given the attractive yields that are currently being offered by our preferred uncorrelated insurance-linked assets. In today's high interest rate environment, and amid a crowded income space, FAI stands out as an attractive and differentiated income option.
