While this abundance and convenience of information have their advantages, it has also brought constant anxiety to investors as they grapple with the decision to buy or sell. Not to mention the pressure they face during unexpected and potentially catastrophic events such as the 2008 Great Financial Crisis where the price of global equity markets declined sharply by -60%. **Meranti Millennium Equity strategy (MME)** is designed to set aside a fixed protection budget to help investors not only stay invested but also top up when markets are at their maximum fear, which is inevitable in the journey of any long-term equity investor.





Power Of Loss Aversion In Both Returns And Emotions

Leverage on the Meranti Millennium Equity (MME) strategy to participate in the global economic growth without worrying about market crashes which can hurt investment returns significantly. The greater the loss, the harder it is for investors to recover:



In times of significant market downturns, such as the Great Financial Crisis of 2008 and the Covid-19 pandemic in 2020, an investor using Dynamic Risk Management (DRM) to invest in global equities would have experienced smaller drawdowns and ultimately achieved a higher return than an investor without such protection.






Geographical Allocation, %

Discerning The Signals From The Noise

A three-pronged research process to identify signals that point us to **sustainable trends** which are underappreciated by the market, which come with **good fundamentals** and **attractive valuation**, with a higher likelihood of outperforming over the long term.





Fundamental

Study financial and economic data (e.g. GDP, unemployment rate, and inflation rate etc.) that may drive market movement to find opportunities with **good fundamentals** that are underappreciated.



Valuation

Picking the right valuation metrics (e.g. price-to-earnings, price-to-book, EV/EBITDA etc.) to spot <u>undervalued opportunities</u> and avoid overpaying for any investment with only good stories.


Seek inflection points in <u>sustainable trends</u> to capture overlooked opportunities and avoid less recognised risks (such as the end of a bond supercycle).

High Level of Active Management

Many actively managed funds underperform because they have a low active share. This happens when a portfolio's holdings are very similar to the referenced benchmark, a practice commonly referred to as 'benchmark hugging'. In contrast, **funds with a high level of active management may have greater potential for outperformance in the long run**, as there is no way any fund can outperform the market if they are investing like the market.

By investing in areas where we have the greatest conviction and applying it to our whole portfolio, we aim to provide better returns over risk through a full market cycle.





Market & Portfolio Developments

Q2 2025 saw strong rallies across most asset classes. MME delivered strong gains of +9.11% during the quarter amid the risk-on environment.

The S&P 500, led by the Magnificent 7, posted its quickest rebound back to all-time highs from a 15% drop on record. Following President Trump's Liberation Day tariff announcement, the S&P 500 plummeted 10% in 2 days, marking only the fourth such drop since World War II. The recovery was even more extraordinary, with the largest intra-quarter decline erased within the same quarter since at least 1928. Overall, the S&P 500 gained 10.6% in Q2, its strongest performance since Q4 2023 and the 11th-best in 25 years.

Navigating with an Active, Flexible Approach

The ability to look beyond U.S. markets has become increasingly critical. Over recent months, U.S. policy unpredictability has shaken investor confidence and led many to question the sustainability of the 'U.S. exceptionalism' trade. MME has maintained a balanced regional allocation which has helped us to capture good performance from the key U.S., Europe, and Asian markets while avoiding concentration risk.

In June, we took profits on Europe which has done well year-to-date (YTD) and added to Korea to benefit from ongoing corporate reforms and reduced political uncertainty following the country's snap elections earlier in the month (which removed political uncertainty). Looking ahead, we're watching key signposts closely - including upcoming earnings results and further direction on U.S. trade policy - to guide positioning.

We remain cautiously optimistic after the strong rally. Further progress on trade and continued earnings resilience would support ongoing upside, and with MME's Dynamic Risk Management (DRM) ready to help manage unexpected tail risks going into the second half of the year.
